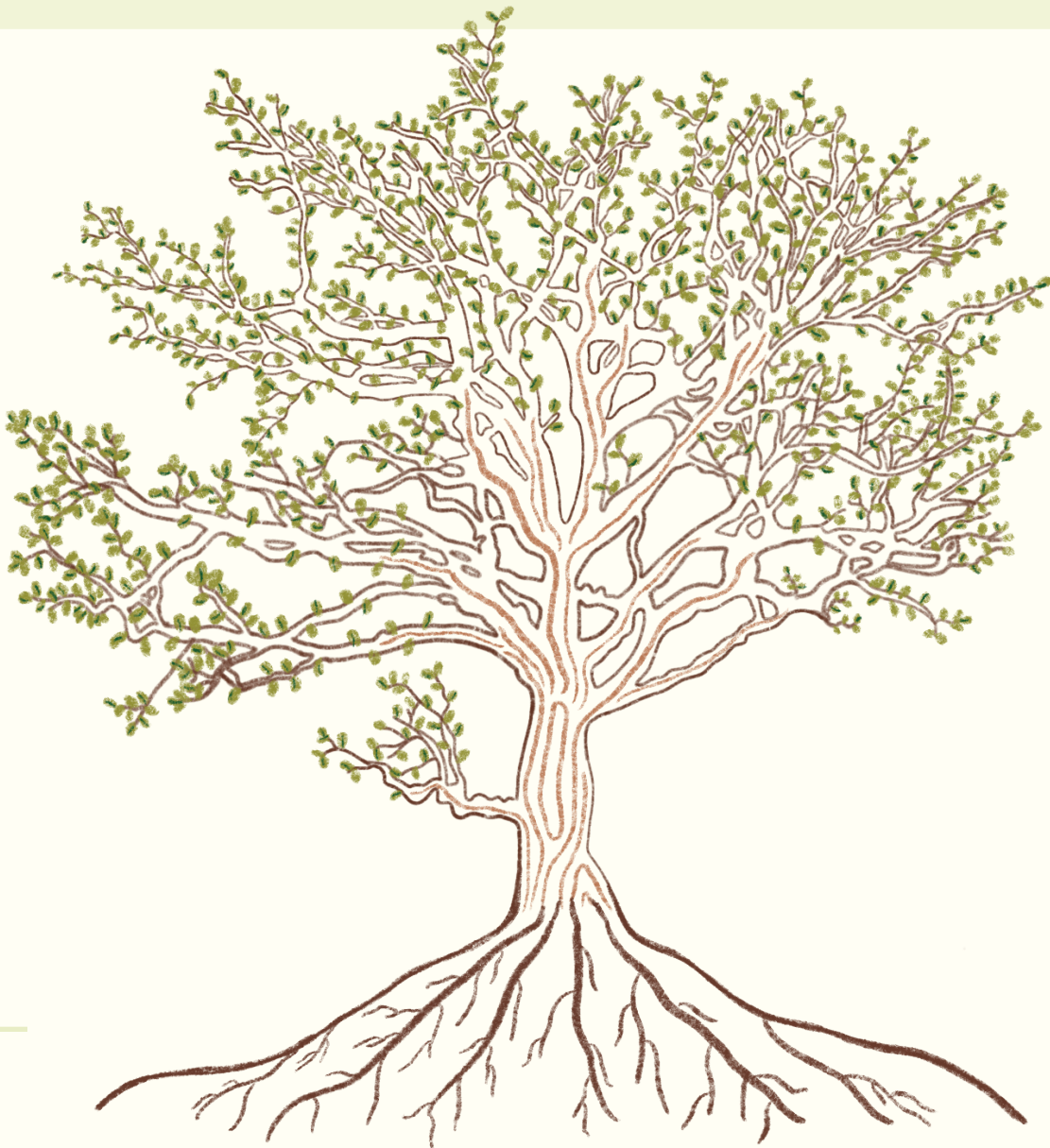

Our Impact in the Community

The Pro Bono Resource Center of Maryland (PBRC) serves a dual purpose:

- To offer **direct legal services** to people in need, and
- To serve as the **hub for volunteer civil legal services** in the state, matching volunteers with non-profit legal services entities, and offering support, training, mentorship, technical assistance.

Direct Services

An estimated 80% of Marylanders who need help with a civil legal problem like housing, immigration, and consumer rights do not receive the help they need. PBRC is committed to closing this justice gap by providing critical legal services to those who would otherwise face life-altering challenges alone. By hosting **over 850 community-based and courthouse clinics** throughout the year, we **closed over 5,600 cases**, preserving home ownership and preventing evictions in low-income communities and offering financial security and safety for consumer debtors, tenants, at-risk homeowners, seniors, and immigrant children and families.



In 2024, PBRC:

- Leveraged volunteers who **provided \$453,250 in donated legal services to low-income Marylanders** who lacked access to legal representation.
- **Impacted 13,994 people** through our direct legal services.
- Achieved a staggering **88-99% success rate** across housing and consumer cases.
- **Avoided \$4,116,433** in costs to clients allowing them to spend limited income on necessities like food, housing, and healthcare.
- **Engaged volunteers who provided 2,090 hours of service**, which helped to meet the heightened demand for legal assistance.



Professional Training & Support Services

PBRC serves as the **state's premier coordinator, trainer, and support center for volunteer civil legal assistance.** For 35 years, PBRC's team has recruited, trained, and mentored volunteer attorneys and other advocates to widen access to legal services. For 25 years, PBRC has also hosted the largest access to justice conference in the state, with last year seeing over 315 registrants.

Client Story:

Gladys' Fight for Livable Housing Conditions



There was snow on the ground when an attorney from the Pro Bono Resource Center of Maryland visited Gladys at her Baltimore City home. CBS had already reported four cold-related deaths in the city that winter; the attorney was determined not to let Gladys become the fifth.

As she entered the home, **she noticed a massive hole where the ceiling had been.** This only exacerbated another of Gladys' woes: **she had no heat.** While Gladys was grateful that no one was harmed during the ceiling's collapse, her landlord simply cleaned up the debris—leaving a crater in her ceiling that exposed the underlying rafters.

The home was freezing—inhabitable, yet, **despite her landlord's awareness of Gladys' dire housing situation, he was suing her for failure to pay rent.** The attorney explained to Gladys that she could sue the landlord for the condition of the home, but Gladys was too afraid to even consider it. The attorney spent two months going back and forth with the landlord's attorney to resolve the issue: insisting that the ceiling and heat be repaired and that Gladys be credited on the ledger.

Ultimately, **the attorney was able to compel the landlord to make all the repairs and credit Gladys' ledger \$4,207 for the open ceiling and lack of heat.** For the PBRC attorney, the image of Gladys smiling, warm and safe in her home, was all the compensation she needed.

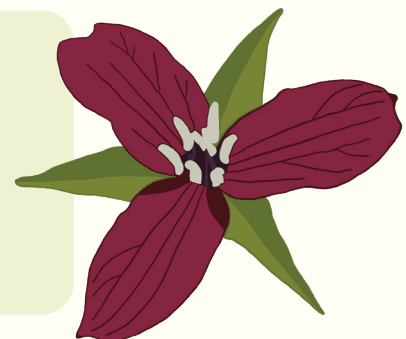
